Course Description:

***“Pre-Malignant Lesions and Early Oral Cancers”***

1. Will be able to recognize subtle early malignant changes in the oral mucosa especially the gingiva and lower lip mucosa.
2. Will learn to recognize early signs of oral HPV driven pre-cancers and malignancies.
3. Will recognize a new class of ulcers caused by immunosuppressive drugs that become malignant if not recognized and treated.
4. Will learn the warning signs and when to biopsy or re-biopsy lichenoid lesions that are transforming.

# About Our Speakers



## “The Role of Effective/Safe Nerve Allografts and MR Detection in the Diagnosis and Management of Traumatic and Planned Trigeminal Nerve Injuries”

### **John Zuniga, DMD**

Dr. Zuniga is a Professor and holds the Robert V. Walker D.D.S Chair in Oral and Maxillofacial Surgery. He joined the faculty in January, 2006. He came to UTSW from the University of North Carolina at Chapel Hill where he served in the School of Dentistry as the Department of Oral and Maxillofacial Surgery Graduate Program Director for 13 years and was the Co-Director of the Oral and Maxillofacial Pain and Neurosensory Disorders program. Dr. Zuniga is the chief of the Division of Oral and Maxillofacial Surgery in the Department of Surgery. The division is dedicated to the improvement of the oral, maxillofacial, dental and craniofacial health of our patients through research, service and education. Dr. Zuniga’s clinical interests are in temporomandibular disorders (TMD) and neurosensory disorders. He is an experienced trigeminal nerve microsurgeon and has performed over 300 nerve repairs for a variety of clinical conditions affecting the trigeminal nerve of the oral and maxillofacial region. Over 60% of his practice is dedicated to treating chronic orofacial pain conditions, including TMD, trigeminal neuralgia, burning mouth syndrome, atypical odontalgia and atypical facial pain. He specializes in the surgical treatment of TMD and can provide services ranging from conservative non-surgical care to total joint reconstruction. He also has a clinical interest in benign pathology, dentoalveolar surgery and trauma of the oral and maxillofacial region. Dr. Zuniga’s major research interests are in chronic and acute orofacial pain and trigeminal neurosensory disorders. Dr. Zuniga is active locally, nationally and internationally in the specialty of oral and maxillofacial surgery. He is a diplomate of the American Board of Oral and Maxillofacial Surgery where he served 6 years on the Examination Committee. He serves on the Editorial Board of several journals and is an ad hoc reviewer for several journals in Neuroscience and Oral and Maxillofacial Surgery. He serves on several committees for the American Association of Oral and Maxillofacial Surgeons and is a voting member of the Dental Products Panel of the Medical Devices Advisory Committee for the Center for Devices and Radiological Health of the Food and Drug Administration.



## “Prescribing Controlled Substances”

### **Joshua Lenchus, DO, RPh, FACP, SFHM**

Joshua D. Lenchus, holds a pharmacy degree from the University of Florida, and graduated from Nova Southeastern University College of Osteopathic Medicine in 2000. Having completed a rotating internship (aka transitional year) at Broward General Medical Center in Fort Lauderdale, he pursued training in internal medicine at Jackson Memorial Hospital in Miami. He recently worked as a hospitalist at Jackson Memorial Hospital for the University of Miami Miller School of Medicine. There he held the rank of associate professor of medicine, anesthesiology, and radiology. From 2007-16, he also served as an associate program director for the internal medicine residency. He has extensive hospital administrative and committee involvement and, in 2012, was elected the first osteopathic President of the Jackson Health System medical staff and chairman of its medical executive committee, in its then-94 year history. He was subsequently re-elected in 2014 and 2016. Outside the hospital, Dr. Lenchus is incredibly involved, serving as a leader in organized medicine at multiple levels, including as President of the Florida Osteopathic Medical Association, Speaker of the House for the Florida Medical Association, past Regent and current Fellow of the American College of Physicians, and Senior Fellow of the Society of Hospital Medicine. He has a passion for health policy, serves on public policy committees, and has presented this topic in a variety of venues, from student groups to corporations. He is a recipient of the Soref Jewish Community Center’s Humanitarian of the Year, Broward College’s Alumni of Distinction award, Florida Osteopathic Medical Association’s Physician of the Year, Hillsborough County Osteopathic Medical Society’s Presidential Achievement Award, and was a faculty inductee into Alpha Omega Alpha honor medical society.



## “Pre-Malignant Lesions and Early Oral Cancers ” & “Potpourri of Oral Pathology”

### **Donald Cohen, DMD, MBA, MS**

Dr. Donald Cohen received his D.M.D. degree from Washington University School of Dental Medicine. He then trained in oral pathology at Temple University School of Dentistry receiving an M.S. in Oral Biology and a Certificate of Specialization in Oral Pathology. He obtained his M.B.A. degree summa cum laude from the University of Nebraska. Dr. Cohen then was awarded a Robert Woods Johnson Faculty Fellowship in Health Care Outcomes and Quality. He is the only D.D.S. to receive this specific fellowship. As part of his fellowship he trained at John Hopkins University in Baltimore, Maryland and LDS Hospital in Salt Lake City, Utah carrying out several pioneering outcomes studies. Dr. Cohen ran a large multi-state oral pathology biopsy service at the University of Nebraska receiving specimens from over 30 states. He also was the director of a very active oral medicine clinic at The University of Nebraska. He has received numerous teaching awards, including several college and university wide. In 2002, Dr. Cohen was nominated for the University of Nebraska system wide Teaching Creativity Award. He is a sought-after speaker and has given over 100 lectures at various state, regional and national meetings.
