## GRAYROBINSON

The Legislature concluded its work for the 2024 Legislative Session and adjourned "Sine Die" as scheduled on Friday, March 1, at 2:25 pm. There were 1,957 member bills, joint resolutions, and proposed committee bills filed for consideration this Session, but only 325 passed both chambers. The Legislature passed the constitutionally mandated state budget, providing for \$117.46 billion in spending for the 2024-25 Fiscal Year. Focus will now shift to Governor Ron DeSantis and which policy bills and appropriations he will sign or veto, as well as the upcoming campaign season.

## **BUDGET**

Lawmakers passed the \$117.46 billion budget by a wide bipartisan margin, a measure that Republican leaders proudly note sets aside \$10 billion in reserves as the recent cash influx of federal aid provided to the state during the COVID pandemic comes to an end. The budget (<u>HB 5001</u>) also provides \$500 million for state debt, \$500 million for a state Emergency Preparedness and Response Fund, and includes a long-sought salary bump for state employees of 3%.

The healthcare section of the budget, typically at the top of the list as the most expensive funding item, totals \$46.5 billion in funding for the 2024-2024 Fiscal Year. It includes more than \$34.7 billion to the Agency for Health Care Innovation, which includes \$333 million for Medicaid provider rate increases, \$2.4 billion to the Agency for Persons with Disabilities, \$4.7 billion to the Department of Children and Families, and \$4.1 billion to the Department of Health. Over \$717 million was appropriated to implement the Live Healthy Act (SB 7016), which passed this year. That includes \$245 million for Medicaid Provider Rate Increases, \$195.8 million in iBudget provider rate increases, a Health Care Screening and Services Grant Program with \$10 million, Florida Reimbursement Assistance for Medical and Dental education, with \$30 million allocated to the medical and \$8 million to dental, among other provisions and programs. This section of the budget also includes \$51.3 million for the Health Care Innovation Council and Revolving Loan Program (SB 7018), \$38.9 million for individuals with disabilities (SB 1758), and \$321 million for behavioral health teaching hospitals (SB 330).

Education is another big-ticket item each year, and this year was no exception, with total funding of \$30.1 billion. The proposed spending plan increases K-12 funding by nearly 7% over the current year, with per-student spending coming in at \$8,958 per student, an increase of 2.75% over last year's budget for a public school funding total of \$28.4 billion. It includes \$1.7 billion for early learning services, \$2.4 billion for the State Colleges, \$243.2 million for the Private Colleges, \$6.8 billion for the State University System, and \$1.05 billion in student financial aid.

The Criminal and Civil Justice budget clocks in at \$7.3 billion. The Department of Corrections will receive \$100 million for upgrades to its beleaguered prison facilities.


The Transportation and Economic Development section totals \$20.4 billion, with \$75 million allocated to the Florida Job Growth Grant Program and \$80 million to Visit Florida, and an additional \$100 million was allocated to the Florida Hometown Hero Program, which assists low-income first-time homebuyers to access affordable housing.

Rounding out the budget, \$9.9 billion was allocated for various Agriculture, Environment, and General Government programs. This includes \$100 million each for Land Acquisition and Land Management programs, \$100 million for the Resilient Florida Grant Program, and \$79 million for the Water Quality Grant Programs

included in <u>SB 1638</u>. The Department of Environmental Protection will receive \$3.4 billion, with \$1.7 billion allocated for various water quality improvement programs. The Flood and Sea Level Rise Program is funded at \$125 million, the Florida Forever programs at \$528.6 million, and water infrastructure improvements at \$178.3 million.

While Republicans have applauded budget writers' efforts, some Democratic members, particularly in the Black Caucus, expressed frustration with disparities in funding in the bill. Rep. Bruce Antone (D-Orlando) echoed concerns he raised when the House first passed its chamber's version of the budget, noting that districts represented by Black lawmakers didn't get much in the way of projects, and said he felt Historical Black Colleges and Universities were shortchanged.

The budget has not yet been transmitted to the Governor, so it remains to be seen how heavily he will exercise his line-item veto power.

## **SESSION HIGHLIGHTS - GENERAL**

#### SOCIAL MEDIA REGULATIONS FOR KIDS

Social media companies that use certain "addictive features" to keep kids scrolling through their content would not be allowed to let Florida kids under 14 have an account and would require parental permission for kids who are 14 and 15 years old who want an account. This compromise language (HB 3) was much less restrictive than the original bill (HB 1) which passed and was subsequently vetoed by the Governor. The original bill would have banned any child under 16 from social media platforms, but DeSantis rejected the original bill over concerns that parents needed a voice in the matter and that the age verification process in the first bill was too intrusive.

Skeptics continue to raise First Amendment concerns about the measure, but backers of the new bill hope that their effort to target the methods the companies use to deliver content rather than the content itself will make the bill constitutionally sound amid an all-but-guaranteed legal challenge. Backers of the legislation likened government efforts to blunt the impact of social media accounts to previous regulations targeting the age at which kids are allowed to drive cars and the fight against tobacco companies, which they argued similarly tried to hook young consumers. One of the bill's House sponsors, Rep. Tyler Sirois (R-Merritt Island), said action needs to be taken to save a generation of kids from the harms of overuse of social media.

DeSantis signed the bill on March 25, and the legislation will take effect on July 1, 2024.

#### **ANNUAL TAX PACKAGE**

The politically popular tax package (HB 7073) passed unanimously this year and offers over \$1.5 billion in broad-based tax savings over the next two years. These include a Governor-backed \$450 million toll rebate program for drivers with more than 35 toll transactions per month. A credit for insurance companies lowering homeowner premiums is expected to save homeowners \$417.5 million over two years. The legislation also provides for five sales tax holidays that seek to save consumers around \$97.3 million, including a two-week back-to-school sales tax holiday, a 30-day "Freedom Month" sales tax holiday, a one-week "Tool Time" sales tax holiday and two separate Disaster Preparedness tax holidays.

#### **LIMITS ON BOOK CHALLENGES**

The House gave its support to a wide-ranging education measure (HB 1285) that includes a limit on objections to books and other classroom materials, a provision cited by Democrats as evidence that Republican measures passed last year allowing for the public to challenge school materials went too far. The bill passed the House on an 84-29 vote. The final product includes a provision stating, "a resident of the county who is not the parent or guardian of a student with access to school district materials may not object to more than one material per month." The House language originally included a \$100 fee for non-parents who make more than five unsuccessful challenges in an effort to cut back on individuals filing frivolous claims, but that provision was not included in the final version, which passed. The initiative has garnered support from Senate President Kathleen Passidomo and Gov. Ron DeSantis.

#### **VACATION RENTALS**

The Legislature passed and sent to Gov. Ron DeSantis a long-discussed measure to preempt local attempts to regulate vacation rentals like those advertised by Airbnb and Vrbo. The bill (SB 280) allows local communities to charge fees for registering vacation properties but sets out rules at the state level for things like maximum occupancy. Sen. Nick DiCeglie (R-St. Petersburg) urged his colleagues to acknowledge that vacation rental

homeowners were a vital part of the economy in some communities and that some attention was due to their property rights. He said he tried to find a balance between the needs of owners who make a living renting out their homes and the communities that have to face complaints from neighbors about unruly behavior at the properties or nuisances like too many cars or too much noise. The bill passed on a 23-16 vote in the Senate, with four Republicans joining 12 Democrats in opposition.

## HIGH PROFILE LEGISLATION WHICH FAILED

Despite the Legislative Session lasting for 60 days, only 325 bills ended up passing. Of the bills that failed, many received significant media attention and are likely to be resurrected in the future.

- **DEFAMATION**: For the second year in a row, Rep. Alex Andrade (R-Pensacola) carried <u>legislation</u> that would have changed the threshold to sue for defamation.
- **ABORTION/PERSONHOOD**: Bills here included a measure (<u>HB 1519</u>) by Rep. David Borrero (R-Sweetwater), which would have banned nearly all abortions in Florida. It never received a committee hearing. <u>SB 476</u> by Sen. Erin Grall (R-Ft. Pierce) initially sought to make it easier for parents who lose an unborn child through negligence to file suit for damages.
- THC CAPS IN MARIJUANA: A Senate Health Policy Committee bill (SB 7050) that would cap delta-9 levels.
- TICKETMASTER MONOPOLY-STIFLING: The <u>legislation</u> would have prohibited live venues from selling tickets
  through just one company and banned arenas and concert halls from selling or transferring passes at prices
  higher than originally listed.
- **TRANSGENDER IDENTITY ERASURE**: <u>HB 1639</u> impacted coverage of gender affirmation surgery and coverage for conversion therapy
- **FLAG BAN**: Sen. Jonathan Martin (R Ft. Myers) filed <u>legislation</u> to prohibit flags representing any political, racial, or ideological viewpoint from being displayed at public facilities.
- **GUN PURCHASE WAITING PERIOD**: <u>HB 17</u> would have required guns to be delivered after a three-day period (excluding holidays and weekends) regardless of whether a background check was completed or not.
- **LOWER AGE LIMIT TO BUY RIFLES**: <u>HB 1223</u> would have lowered the age from 21 to 18 for long gun purchases.
- **COUNTY COMMISSIONER TERM LIMITS**: Filed for multiple consecutive sessions, the bill sought to impose 8-year term limits for County Commissioners.
- CONSTITUTIONAL AMENDMENT THRESHOLDS: House Joint Resolution 335 would have raised the required
  vote threshold for passing a constitutional amendment on the statewide ballot to 66.67%, or two-thirds, of
  voters voting on the measure to pass.
- **SOVEREIGN IMMUNITY CAPS**: Another <u>attempt (SB 472)</u> to increase the monetary caps on lawsuit damage awards against governmental entities failed to cross the finish line again this year.

## FSOMS HIGH PRIORITY BILLS WHICH PASSED

#### **HB 855** - DENTAL SERVICES

by Rep. Lawrence McClure (R-Plant City) and SB 302 by Sen. Jim Boyd (R-Bradenton)

The bill requires every dentist and any individual, partnership, corporation, or other entity that provides dental services through telehealth to make available the dentist's name, telephone number, after-hours contact information for emergencies, and upon request, licensure information.

Additionally, the bill requires that there must be a dentist of record who will remain responsible for all treatment of any patient, regardless of who is rendering services. The bill creates a definition for advertisement and requires if any services are provided via telehealth, that the ad must include a specific disclaimer that an in-person exam is recommended if the ad is for:

- Taking of impressions or dental scanning of the teeth/jaw directly or indirectly.
- Placing an appliance or structure in the mouth or adjustment of the appliance/structure.
- Correcting malformations of teeth or jaws.

Finally, the bills establish grounds for discipline by the Board of Dentistry (BOD) by creating a standard that would require the dentist of record to perform an in-patient exam and x-ray before using said products or failing to disclose the required contact information to the patient.

HB 855 passed unanimously in both chambers and is awaiting presentation to the Governor. If approved, the bill will take effect July 1, 2024.

#### **SB 938 - DENTISTRY**

by Sen. Clay Yarborough (R-Jacksonville) and HB 547 by Rep. Thad Altman (R-Indian Harbour Beach)

This bill will make several updates to the Dental Practice Act, which have been discussed and mutually agreed upon by the Florida Dental Association (FDA) and the Department of Health (DOH). Specifically, the bill revises sections of Chapter 466 by:

- Deleting language requiring dental students who have completed the coursework necessary to prepare to pass the American Dental License Examination (ADEX) to wait until their final year of dental school to apply for licensure.
- Deleting the National Board of Dental Examiners (NBDE) dental examination as obsolete, replacing it instead with the examination administered by the Joint Commission on National Dental Examinations (JCNDE).
- Deleting an alternate pathway to dental licensure by having an active Florida health access dental license and meeting specific additional practice requirements.
- Deleting language relating to ADEX scores for applicants only being valid for 365 days after the date the official examination results are published.
- Requiring that an out-of-state licensed dentist applying for licensure in Florida must disclose to the BOD during the application process, rather than submit proof, whether he or she has been reported to the National Practitioner Data Bank, the Healthcare Integrity and Protection Data Bank, or the American Association of Dental Boards Clearinghouse.

- Removing the requirement that out-of-state dentists who apply and receive a license must engage in full-time practice of dentistry inside the geographic boundaries of the state for 1 year after licensure.
- Allowing any person who fails the examination for licensure as a dentist or dental hygienist to retake the exam.

SB 938 passed unanimously in both chambers and is awaiting presentation to the Governor. If approved, the bill will take effect July 1, 2024.

## **HB 975** - BACKGROUND SCREENING REQUIREMENTS FOR HEALTH CARE PRACTITIONERS

By Rep. Dana Trabulsy (R-Fort Pierce) and Rep. Melony Bell (R-Ft. Meade) and SB 1008 by Sen. Erin Grall (R-Fort Pierce)

This bill will require all health care practitioners, including dentists, to undergo a background screening as a requirement for licensure. Florida law currently requires physicians, osteopathic physicians, chiropractors, podiatrists, certified nursing assistants, nurses, athletic trainers, and massage therapists to undergo a background screening, with fingerprinting, for licensure. These bills would expand that requirement to include all DOH-licensed healthcare practitioners.

Any practitioner licensed prior to July 1, 2024, would be required to complete the background screening process by July 1, 2025. Applicants subject to the screening are required to pay for both the processing costs as well as the cost of retaining the fingerprints. Once licensed, practitioners in screened professions pay \$43.25 every five years for fingerprint retention by the Care Provider Background Screening Clearinghouse, which is used by state agencies for statutorily required screenings. The total cost amounts to approximately \$61.25 per person for both screening and retention,

All screenings received would be entered into the Clearinghouse and require criminal history review through DOH. This would impact current non-screened professions and licensees who do not have updated screenings in the clearinghouse. Under the bill, 699,754 licensees in renewable status would have to complete the fingerprinting process of background screening within the year, and an additional 42,467 initial applicants would need to be screened.

Additionally, the bill adds eight offenses to the statutory list of 52 offenses that can disqualify a person from employment in certain regulated professions if he or she has been the subject of certain legal actions regarding such offenses.

The bill has not yet been presented to the Governor, but if signed into law, would have an effective date of July 1, 2024.

#### **SB 7016 - HEALTH CARE**

by Sen. Colleen Burton (R-Lakeland) and HB 1549 by Rep. Michael Grant (R-Port Charlotte)

Dubbed the "Live Healthy Act" by Senate President Kathleen Passidomo, for whom this bill was a top priority this Session, this legislation is designed to grow Florida's healthcare workforce, increase access, and incentivize innovation.

Throughout the legislative process, as this bill moved through its committees of reference, multiple amendments were adopted to SB 7016, several of which impacted dentistry:

## **Dental Student Loan Repayment Program**

- As originally filed, the Senate bill increased the current funding amount for the Dental Student Loan Repayment Program of \$1.8 million to \$13 million, but that amount was reduced to \$8 million via a floor amendment.
- Current law caps the number of dentists allowed to receive the award to 10 per state fiscal year. DOH has
  not yet implemented the DSLR Program but intends to rework its online portal (FRAMEworks) to implement
  by 2.1.24.
- Both versions of the bill expand DSLR recipient eligibility to include dental hygienists and expand employment
  eligibility beyond just a public health program to include private practices that serve Medicaid and other lowincome recipients.
- The bill further expands eligibility requirements to include participating in 25 hours per year volunteering to
  provide dental services in a free clinic located in a dental health professional shortage area or medically
  underserved area or through a bro-bono program approved by BOD.
- The awards have been modified to be allocated at 20% of the applicant's principal loan amount at the time of application not to exceed \$7,500 per year per eligible hygienist but maintain the \$50,000 annual cap for dentists.
- The bill adds a repeal date of the DSLR program on July 1, 2034.

#### Medicaid Reimbursement Rates for Dental Services

The bills provide \$35 million for a dental fee increase in the Medicaid program but add additional language that directs the Agency for Health Care Administration (AHCA) to develop a plan to increase Medicaid reimbursement rates for preventative dental care services by September 1, 2024. The bill directs the dental plans that participate in the Statewide Medicaid Managed Care program to pass the fee increase to the dental providers.

In honor of Sen. Passidomo's father, who passed away last year, an amendment was adopted renaming a portion of the bill for her parents, creating the "Dr. and Mrs. Alfonse and Kathleen Cinotti Health Care Screening and Services Grant Program." Dr. Cinotti, who was an ophthalmologist, valued and promoted volunteer health care programs throughout his career. That provision expands access to no-cost health care screenings or services for the general public facilitated by nonprofit entities.

In total, the Live Healthy Act appropriates \$717 million to various programs contained within the bill. The bill was transmitted to Governor DeSantis on March 12 and was signed into law at a press conference on March 21, 2024, with both <a href="Passidomo">Passidomo</a> and <a href="DeSantis">DeSantis</a> praising the legislation and its impacts on Floridians.

## **SB 1600** - INTERSTATE MOBILITY

Licensure by endorsement is the most common alternative to licensure by examination in Florida. Licensure by endorsement is an expedited licensure process that allows a health care professional to become licensed in Florida based upon holding a substantially equivalent or similar health care professional license from another state.

Currently, 20 healthcare professionals are regulated by DOH, and the boards are legislatively authorized to offer licensure by endorsement. Seventeen are not, including dentists.

This bill creates the "Mobile Opportunity by Interstate Licensure Endorsement Act" or "MOBILE Act," which requires DOH to issue a license or certificate by endorsement within 7 days of receipt of all required documents for any of the 59 healthcare professions regulated by the Department when the applicant meets specific criteria:

- Submits a completed application.
- Holds an active, unencumbered license issued by another state, the District of Columbia, or a possession or territory of the U.S. in a profession with a similar "scope of practice," as determined by the board or the DOH, as applicable. Section 456.0145(2)(a)2., F.S., defines the term "scope of practice" as the full spectrum of functions, procedures, actions, and services that a health care practitioner is deemed competent and authorized to perform under a license issued in this state."
- Has obtained:
  - A passing score on a national licensure examination or holds a national certification recognized by the board or the DOH if there is no board, as applicable to the profession for which the applicant is seeking licensure; or
    - If the profession applied for does not require a national examination or national certification and the applicable board, or the DOH, if there is no board, determines that the jurisdiction in which the applicant currently holds an active, unencumbered license:
      - Meets established minimum education requirements; and
      - The work experience and clinical supervision requirements are substantially similar to the requirements for licensure in that profession in Florida.
- Has actively practiced the profession for at least three years during the four-year period immediately preceding the application submission.
- Attests that he or she is not, at the time of application submission, the subject of a disciplinary proceeding in a jurisdiction in which he or she holds a license or by the U.S. Department of Defense for reasons related to the practice of the profession for which he or she is applying.
- Has not had professional disciplinary action taken against him or her in the seven years preceding the application submission application.
- Meets the financial responsibility requirements of s. 456.048, F.S., or the applicable practice act; and
- Submits a set of fingerprints for a background check pursuant to s. 456.0135, F.S., or the applicable practice
  act. The bill requires the DOH to verify the information above submitted by the applicant using the National
  Practitioner Data Bank.

The bill authorizes the board, or the DOH if there is no board, to revoke a license upon finding that the licensee provided false or misleading material information or intentionally omitted material information in an application. The bill authorizes the board, or the DOH if there is no board, to require an applicant to successfully complete a state jurisprudential examination on Florida laws and rules that regulate the applicable profession if the applicable practice act requires such examination.

The bill requires the DOH to submit an annual report by December 31 to the Governor, the President of the Senate, and the Speaker of the House of Representatives, which provides all of the following information for the previous fiscal year, distinguished by profession:

- The number of applications for licensure received under the MOBILE Act;
- The number of licenses issued under the MOBILE Act;
- The number of applications submitted under the MOBILE Act which were denied and the reason for such denials; and
- The number of complaints, investigations, or other disciplinary actions taken against health care practitioners who are licensed under the MOBILE Act.

The bill requires each applicable board, or the DOH if there is no board, to adopt rules to implement the MOBILE Act within six months after its effective date, including rules relating to legislative intent provided under s. 456.025(1), F.S., and the requirements of s. 456.025(3), F.S., both of which contain provisions for the assessment of fees from applicants and licensees in health care professions.

The bill amends current law for licensure by endorsement in various practice acts to conform to provisions found in the MOBILE Act and to retain statutory guidance for the maximum amounts of related fees.

The bill provides that, notwithstanding the changes made to the Florida Statutes by the MOBILE Act, a board or the DOH, as applicable, may continue processing applications for licensure by endorsement as authorized under the Florida Statutes (2023) until the rules adopted by such board or the DOH to implement the changes made by the MOBILE Act take effect or until six months after the bill's effective date, whichever occurs first.

If approved by the Governor, the bill takes effect July 1, 2024.

## FSOMS HIGH PRIORITY BILLS WHICH FAILED

### HB 1173/SB 1254 - DENTAL THERAPY

By Rep. Linda Chaney (R-St. Petersburg) and Sen. Jay Collins (R-Tampa)

This legislation would authorize dental therapists to practice in the state of Florida, allowing someone right out of high school who has gone through three years of dental therapy training to perform numerous dental procedures such as extractions, partial root canals, and administer local anesthesia.

This proposal had existed in some iterations since 2018 when it was filed by incoming House Speaker Danny Perez. We have been successful in defeating the legislation each year it has been filed.

In committee, proponents argued that there is a shortage of dentists. There is not a shortage of dentists in Florida; however, there is a maldistribution of where dentists are located. This underscores the importance of implementing the Dental Student Loan Repayment Program to help increase access to dental care in rural and underserved areas. Proponents will falsely compare dental therapists to nurse practitioners and physician assistants. Nurse practitioners and physician assistants have more extensive and substantive education and training than what a dental therapist would receive. Proponents of dental therapy state that they will focus on the underserved population. This statement should be concerning if the state chooses to allow individuals with less training to be responsible for people who may have compromised health conditions. Dentists are trained to be comprehensive health care providers who not only examine teeth but are trained to ensure that oral health does not compromise overall health.

### Additionally, the bills:

- Create section 466.0025 allowing dental therapists to practice in Florida if they've met the following requirements:
  - Must be 18 years of age or older.
  - Graduated from a dental therapy college or school accredited by the American Dental Association Commission on Dental Accreditation or its successor entity (if any) or any other dental therapy accrediting entity recognized by the USDOE.
    - If they are applying before 1/1/29, the board must approve the applicant's program if it was administered by an accredited dental or dental hygiene program and that school certifies to the Board that the applicant's education "substantially conformed" to the standards established by the ADAC-DA.
  - Successfully completed a dental therapy practical or clinical exam produced by ADEX or its successor, if any.
    - If the applicant fails to pass the exam after 3 attempts, they cannot retake it unless they complete additional education requirements as established by the board.
    - If ADEX has not established a dental therapy exam, the board must administer or approve an alternative examination.
  - Has not been disciplined by "a" board, except for citation offenses or minor violations.
  - Has not been convicted of a felony or misdemeanor related to the practice of health care.
  - Has completed the state exam on laws and rules regulating dental therapy.

- Allows for an applicant from out of state who meets the requirements or who has completed a comparable exam approved by their own jurisdiction to be licensed if the board determines the exams to be substantially similar.
- Create section 466.0227 Dental Therapy Scope of Practice
  - Requires general supervision of a licensed and practicing dentist, to the extent authorized by that dentist, as provided within the terms of their written collaborative agreement. That dentist is responsible for all services performed by the DT.
  - o Dental therapy services include the following if authorized by the collaborative agreement:
    - All services, treatments, and competencies identified by the ADAC-DA.
    - State-specific services, if the dental therapist's education included curriculum content satisfying the ADAC-DA criteria for:
      - Evaluating radiographs.
      - Placement of space maintainers.
      - Pulpotomies on primary teeth.
      - Dispensing and administering nonopioid analgesics, including nitrous oxide, antiinflammatories, and antibiotics.
    - Oral evaluation and assessment of dental disease and formulation of an individualized treatment plan.
  - A collaborative agreement must include the following info:
    - Practice settings where services can be provided to the population to be served.
    - Any limitations on services provided, including the level of supervision required (including telehealth).
    - Age-specific and procedure-specific practice protocols for the DT, including case selection criteria, assessment guidelines, and imaging frequency.
    - A procedure for maintaining records.
    - A plan to manage medical emergencies.
    - A quality assurance plan for monitoring care.
    - Protocols for administration of medicines.
    - Criteria related to care for patients with specific medical conditions or complex medical histories, including requirements for consultation before the initiation of care.
    - Supervision criteria of dental therapists.
    - A plan for the provision of clinical resources and referrals in situations beyond the capabilities of the DT.
  - The supervising dentist shall determine the number of hours of practice that a DT must complete under direct or indirect supervision of before the DT may perform any of the services authorized by the Collaborative Agreement.
  - The supervising dentist can restrict or limit the DT's practice in the written collaborative management agreement to be less than the full scope as authorized.
  - Allows a DT to provide services to a patient before the supervising dentist examines the patient if the authority, conditions, and protocols are established in a written agreement and if the patient is subsequently referred to a dentist for any additional services beyond the DT's scope.
- If an applicant fails the practical or clinical exam by only one part or procedure, they may be required to retake only that part of the exam; but if they fail more than one part, they must retake the entire examination.

- Dental therapists would be required to complete 24 hours but no more than 36 biennially of CE in dental subjects approved by the board.
- Allow a dental therapist under the "general" supervision of a dentist to administer local anesthesia, including intraoral block anesthesia or soft tissue infiltration anesthesia if they've completed the required course and is certified in basic/advanced cardiac life support.
- Effective 28 months after the first dental therapy license is granted by BOD, the bills would require the Board to appoint a Council on Dental Therapy, chaired by at least one Board member, and must include 3 dental therapists.
- DOH must submit a progress report to the President & Speaker by 1/1/27 and a final report 4 years after the first dental therapy license is issued. It must include:
  - o Progress made to implement training programs, licensure & Medicaid reimbursement.
  - Data showing the effects, including:
    - Access to care.
    - Costs.
    - Quality & Safety.
    - Recommendations for any reform re DT.
    - Any other info deemed appropriate.

Each bill received three committees of reference. HB 1173 was placed on the Healthcare Regulation Subcommittee on January 24 and passed with a 14-3 vote. It was subsequently taken up by the House Health Care Appropriations Subcommittee, where it also passed on a 9-5 vote. However, it did not progress to its final committee of reference, as the Senate bill never received a hearing, thanks to Senate Health Policy Chair Colleen Burton's (R – Lakeland) steadfast resolve not to hear the legislation. Members of the FSOMS lobby team were present at each hearing and publicly registered the Society's opposition to the legislation at both stops.

Although the legislation has once again failed this year, the bills may have a stronger chance of passage during the next two Sessions, as the original sponsor of the bill, Rep. Danny Perez (R – Miami), will become Speaker of the House after the 2024 General Election.

#### HB 1295/SB 1112 - HEALTH CARE PRACTITIONER TITLES AND DESIGNATIONS

By Rep. Ralph Massullo (R-Inverness) and Sen. Gayle Harrell (R-Stuart)

This legislation passed last year and was vetoed by the Governor without explanation. The sponsors re-filed the legislation for consideration again this Session, keeping the language we worked on last year intact.

The bill defines "advertisement," "educational degree," "misleading, deceptive, or fraudulent representation," and "profession". The bill also provides exceptions for certain professions and certain titles and provides that practitioners may use titles and specialty designations authorized under their respective practice acts. Specifically, the bill allows for the use of the following titles for practitioners licensed under Chapter 466, Florida Statutes:

- Doctor of medicine in dentistry;
- Doctor of dental medicine;
- D.M.D.;
- Doctor of dental surgery;

- D.D.S.;
- Oral surgeon;
- Maxillofacial surgeon;
- Oral and maxillofacial surgeon;
- O.M.S.;
- Oral radiologist;
- Dental anesthesiologist;
- Oral pathologist; and
- "any other titles or abbreviations authorized under his or her practice act."

The legislation also included a provision that states that a practitioner's failure to wear a name tag, which must include his or her name and profession, when treating or consulting with a patient is grounds for discipline unless he or she is providing services in his or her own office where the practitioner's license is prominently displayed in a conspicuous area, and the practitioner verbally identifies himself or herself to all new patients by name and profession in a manner that does not constitute the unlicensed practice of medicine. Any advertisement naming a practitioner must include the practitioner's profession and educational degree. The practitioner regulatory boards must adopt rules to determine how their practitioners must comply with the bill.

Despite both bills clearing all committees of reference and passing both chambers of reference at the initial pass, the House amended the Senate version of the bill when it came over, and the Senate refused to concur with the changes made and asked the House to recede the amendment. The House instead let the bill die in returning messages.

#### **HB 1561** - OFFICE SURGERIES

By Rep. Demi Busatta-Cabrera (R-Miami) and SB 1188 by Sen. Ileana Garcia (R-Miami)

Last Session, the Legislature passed a law codifying standards of care for "Brazilian Butt Lifts," following multiple deaths in South Florida resulting from the procedure (Chapter 2023-307, Laws of Florida). That law went into effect July 1, 2023. For the 2024 Legislative Session, bills were filed which were intended to further clarify the law.

As originally filed and upon review, it was determined that the bills would not impact dentists or OMSs. However, as the bill was scheduled to be heard in its final committee of reference, Senator Garcia filed a strike-all amendment which added a massive expansion of the applicability of office surgeries under a new statute being created in Chapter 458, much of which dealt with requirements of having an anesthesiologist present to assist in the defined Level II and Level III office surgeries, among other requirements which could have impacted any dual degree OMS practicing under their medical license.

The FSOMS lobby team crafted amendment language to exempt dually licensed OMSs from the proposed provisions in the bill. Senator Garcia agreed to the amendment and filed language which made this correction. However, after being temporarily postponed in committee, once it was placed back on the committee agenda, a new strike-all amendment was filed, which returned the bill more closely to its original form, which only pertained to liposuction procedures and gluteal fat grafting and our practitioners were once again not impacted by the bill.

The legislation ultimately passed and will be sent to Governor DeSantis for his consideration.

### HB 257/SB 810 - AUTONOMOUS PRACTICE BY A CERTIFIED REGISTERED NURSE ANESTHETIST

By Rep. Mike Giallombardo (R-Cape Coral) and Sen. Blaise Ingoglia (R-Spring Hill)

APRNs are generally required to practice under a supervising physician's protocol and only to the extent that the written protocol allows. In 2020, the Legislature passed legislation authorizing APRNs meeting certain criteria to practice "autonomously," or without physician supervision or a supervisory protocol, in specified settings. The Council on Advanced Practice Registered Nurse Autonomous Practice was established to recommend standards of practice for autonomous APRNs to the Board of Nursing. APRNs registered for autonomous practice may only provide "primary care" services and limited acts related to their respective specialty without a physician's supervisory protocol.

CRNAs provide pain medication, specifically anesthesia, to patients before, during, and after surgery. CRNAs must operate under an established supervisory protocol to perform acts related to the administration of anesthesia. CRNAs may register for autonomous practice; however, they may only autonomously provide primary care services. There are 7,567 CRNAs currently registered to practice in Florida, of which 72 are registered for primary care autonomous practice.

The legislation would have authorized autonomous CRNAs to perform CRNA-specific acts, such as conducting a pre-anesthesia evaluation, ordering and administering the anesthetic as determined appropriate, monitoring and interpreting the patient's vital signs, and managing the patient during surgery and recovery without an established

supervisory protocol. The bills exempted autonomous CRNAs practicing in certain licensed facilities from the requirement that they only administer anesthesia under onsite physician or dentist supervision and within an established protocol unless such facility chooses to require such a protocol. The bills added anesthesia to the list of primary care practices that an APRN may engage in autonomously and added anesthesia to the list of primary care specialties that an autonomous APRN may be practicing in to be eligible for the Medical Education Reimbursement and Loan Repayment Program.

Neither bill ever received a committee hearing, and the legislation ultimately died.

#### HB 63/SB 410 - PROTECTION FROM SURGICAL SMOKE

by Rep. Marie Woodson (D-Pembroke Pines) and Sen. Ileana Garcia (R-Miami)

Surgical smoke is the gaseous by-product produced when tissue is dissected or cauterized by heat-generating devices such as lasers, electrosurgical units, ultrasonic devices, and high-speed burrs, drills, and saws. Surgical smoke contains chemicals, blood and tissue particles, bacteria, and viruses and has been proven to exhibit potential risks for surgeons, nurses, anesthesiologists, and technicians in the operating room due to long-term exposure.

The bills required hospitals and ambulatory surgical centers to adopt and implement policies by January 1, 2025, that require the use of a smoke evacuation system during any surgical procedure that is likely to generate surgical smoke. Smoke evacuation systems must effectively capture, filter, and eliminate surgical smoke at the site of origin before the smoke makes contact with the eyes or respiratory tract of occupants in the room.

The House bill cleared all committees of reference unanimously and passed the House on a 115-1 vote, but the Senate bill never received a hearing in Fiscal Policy, its second committee stop, and the legislation died.
